

#### FINANCIAL SERVICES

A global financial institution frequently required internal data collection and investigation in response to regulatory action and litigation. The bank insourced large volumes of work it used to send out to external providers. Nuix software provided an unmatched ability to collect, process, and analyze large volumes of data within a reasonable time.

#### MANUFACTURING

A multinational electronics manufacturer needed to collect, cull and search data belonging to 15,000 employees in its South Korean office, in relation to a major lawsuit. The company engaged Nuix to process, search and export the data which was in more than 50,000 Lotus Notes NSF files and in a combination of English and Korean languages.
